<u>SUMMARY²</u>

On May 2, 2019, Michael Moscaritolo (respondent), after a trial by jury, was convicted in the Plymouth County Superior Court of one count of unarmed burglary and assault in violation of M.G.L. c. 266, § 14; one count of unarmed robbery in violation of M.G.L. c. 265, § 19(b); and five counts of larceny of a firearm in violation of M.G.L. c. 266, § 30(1). On February 5, 2020, after a trial by jury, the respondent was convicted in the Plymouth County Superior Court of one count of felony murder in violation of M.G.L. c. 265, § 1.

On June 1, 2020, the respondent filed an affidavit of resignation with the Board of Bar Overseers. In his affidavit, the respondent acknowledged that he was convicted of the above crimes and that they were "serious" as defined by Supreme Judicial Court Rule 4:01, § 12(3).

On June 8, 2020, the Board of Bar Overseers unanimously voted to recommend that the respondent's resignation be accepted and that he be disbarred, retroactive to December 13, 2019, the date of a temporary suspension entered pending further disciplinary proceedings. On June 26, 2020, the Supreme Judicial Court for Suffolk County (Lowy, J.) so ordered.
